- An application is submitted to the local service provider to determine program eligibility
- An energy audit of the home is conducted to identify needs
- The home is weatherized by our qualified SCCAP carpenters
- Home is inspected to assure quality of work completed



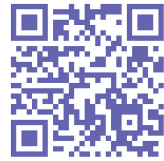

## WEATHERIZING SERVICES

The Schoharie County Community Action Program's Weatherization Assistance Program addresses and/or tests the following measures:

- Air infiltration and exfiltration
- Base load usage
- Conductive heat loss
- Heating appliances
- Heating distribution
- Health and safety issues
- Indoor air quality tests
- Ventilation
- Insulation
- Air sealing
- Refrigerator testing and/or replacement
- Checking and/or replacing water heaters
- Installing LED bulbs, pipe wrap, water heater wrap, faucet aerators, and shower heads
- Replacing windows and doors for mobile homes
- Providing window air conditioners for customers with a medical need

## GUIDELINES

Based on the NYSHCR guidelines, if your home was weatherized at least 15 years ago, you may be eligible to have it re-weatherized!

## FEE FOR SERVICE PROGRAM

We offer the following services to the community. No income eligibility requirements!

- Whole House Energy Audit & Results: \$900 for homes up to 2,000 sq. ft. Our Testing and Evaluation Includes:
  - Heating system and distribution
  - Air leakage and insulation
  - Refrigerator, lighting, ventilation, and health & safety issues
  - BTU per sq. ft. per heating degree day (pre- and post-test figures)
- Blower Door Test: \$750 – Includes air change calculation and report
- Attic Insulation (Open Blow):
  - Blown-in cellulose insulation
  - 6" cellulose insulation – \$1.95 per sq. ft.
  - 12" cellulose insulation – \$2.95 per square foot (prices includes material and labor)
